**Specifications:**

1. Artists may enter up to three works in each of the three divisions. See first page for division descriptions
2. Two-dimensional works must be matted, gallery wrapped if on canvas, or framed and wired for hanging. Three-dimensional artwork must stand alone, be assembled and ready to exhibit. Works are not to exceed 60" in any direction, including framing. Artwork cannot be smaller than 9" by 10" in size in any direction.
3. All works must be original and completed within 5 years of the opening date of the exhibition. No previously submitted Northwest Artist's Exhibit Competition artwork will be accepted.
4. Please indicate sale price for all work submitted. For works listed as not for sale (NFS), please list a value for insurance purposes.
5. The Wilkes Art Gallery retains a 40% commission on works sold in the gallery. Please price your work accordingly.
6. Artist's signature on each entry form verifies accuracy of information.
7. Works not picked up by September 30, 2021 will become property of Wilkes Art Gallery.
8. Entry labels must be attached to the back of each work, at the center of the top of the piece. The manifest must be completed and submitted to Gallery staff.
9. Artists must be 16 years or older and live in Northwest NC.

## **Northwest Artist's Check list**

- 1. Hanging hardware much be on back of artwork, or stands for sculptures if sculpture does not stand on its own, fiber artwork much have materials to hang artwork. The artwork should be ready to hang.**
- 2. Labels on top center back of the artwork.**
- 3. Make sure you choose artwork that has not been in the Northwest Artist's Exhibit before.**
- 4. Make sure the artwork was completed in the last 5 years.**
- 5. The artwork should not exceed 60" in any direction or is not smaller than 9" by 10".**
